### **Evicted in Indiana Webinar Series & Reading Guide**

Researchers find <u>248,000-313,000</u> Hoosier households are at risk of eviction due to COVID-19. Another recent study <u>estimates</u> 150,000 evictions will be filed by January 2021 and \$376,000,000 – \$485,000,000 will be lost in rent shortfall in Indiana, unless policy solutions are implemented.

#### Statewide Rental Assistance Program Has Re-Opened

On October 13, Indiana reopened its Rental Assistance Portal for the first time since closing on August 26. While the Hoosier Housing Needs Coalition applauds this needed step, the restrictions now attached to the portal funds will likely mean that very few of the <a href="nearly quarter-million">nearly quarter-million</a> Hoosier households at threat of eviction will be helped. The Coalition renews its calls for Governor Holcomb to create a coordinated <a href="COVID-19 Housing Stability Policy">COVID-19 Housing Stability Policy</a> Plan and leverage some of over \$1 billion in CARES Act funds still sitting on the table to ensure no Hoosier is evicted or made homeless due to the pandemic.

While reopening the rental assistance program is good news for some Hoosiers, the eligibility requirements are far more restrictive now. The state's COVID-19 rental assistance was initially funded using Coronavirus Relief Funds (CRF), which carry a great deal of flexibility. The newly added ESG funds not only have their customary and significant federal restrictions attached to them but also new state rules added to the program. Those in need are encouraged to apply regardless of the restrictions to document compliance with the CDC Eviction Moratorium. Read more here.

#### **Updated FAQ for CDC's Eviction Moratorium**

On Friday, September 4, the CDC's National Eviction Moratorium took effect; the agency has since <u>released an updated FAQ</u>. Prosperity Indiana has created a <u>Federal Eviction</u> <u>Moratorium Flyer</u> for renters to know if they are covered and their responsibilities. In case you missed it, Pi released a blog post last month on <u>what the moratorium means for Hoosiers</u>.

To be protected, qualified renters facing eviction should immediately provide a signed declaration to their landlords. ## New Data Shows Owed Rent and More

New <u>data</u> analyzed by the Center on Budget and Policy Priorities improvement loan to homeowners who live in a qualified neighborhood in Marion County. The loan is for up to \$3,000 loan at an interest rate of 2.00%/2.00% APR on a 5-year fixed term with interest-only payments at \$5.00 per month. There is no borrower cost to create the loan.

Loan forgiveness includes one-third of the loan forgiven after 12 payments paid as agreed, two-thirds of the loan forgiven after 24 payments paid as agreed, and the full balance of the loan forgiven after 36 payments paid as agreed.

Funds must be used for home improvement and receipt of work performed will be required.

strengthen its infrastructure to respond to an increased need for housing and support services for domestic violence survivors. Coburn Place is prioritizing innovational programming leadership by incorporating a chief impact and innovation officer, growing the direct services team, and solidifying Coburn Place's service delivery model as a best practice at the local, state, and national level.

Recent staff updates include Sudha Sankar, Ph.D., becoming responsible for the strategic design, planning, organization, and product generation for the newly formed Impact and Innovation Division of Coburn Place. Dr. Sankar will assume the role of Coburn Place's Chief Impact and Innovation Officer in mid to late 2021.

Dena Simpson is the Domestic Violence Housing First Coordinator who will be focusing on ensuring the model of "Domestic Violence Housing First" is integrated into Coburn Place's housing services.

<u>View Coburn Place's</u> <u>website with the new logo</u> <u>here.</u> (CBPP) found that one in three adults had trouble paying for usual household expenses in the last seven days; the difficulty is particularly acute for Black, Asian, and Latino adults. CBPP found that 48 percent of Black adults and 45 percent of Latino adults report difficulty covering regular expenses, compared to 25 percent of white adults.

The report also includes a state-by-state breakdown of food insecurity, people behind on rent, difficulty paying usual expenses, and more.

## PPP Loan Forgiveness Applications

The SBA released a new loan forgiveness application that streamlines the forgiveness process for PPP loans of \$50,000 or less. Borrowers that use the new application will be exempt from any reductions in the borrower's loan forgiveness amount based on reductions in full-time equivalent (FTE) employees or reductions in employee salary or wages that would otherwise apply.

Final Rule on the simpler forgiveness

## Health of the U.S. Nonprofit Sector

The annual Independent Sector's Health of the U.S. Nonprofit Sector is a new resource that compiles important information on the current health of the U.S. nonprofit sector across multiple dimensions in a single, accessible format.

According to Independent Sector, "Most information on the health and wellbeing of nonprofits is found across multiple, single-issue reports, which makes it difficult to get a complete picture of overall sector health. This annual review makes a broad set of measures that are easily accessible and presented side-byside, so stakeholders and key decision makers can see the most accurate snapshot of the state of civil society."

### Nonprofits led by people of color face growing challenges

A survey of 433 nonprofit leaders of color and 41 interviews from the Building Movement Project found that organizations led by people of color have been preparing for multiple crises, including the pandemic.

Seventy-nine (79)
percent of participants
said they were
responding to needs in
communities directly
impacted by COVID-19,
and 87 percent indicated
that they were assisting
people impacted by the
economic fallout from the
pandemic.

Prevention Steps for Close Contacts

#### **General Information & Precautions**

- Wash your hands for 20 seconds.
- Clean and disinfect frequently touched surfaces daily.
- Avoid touching your face.
- Encourage teleworking when feasible.
- Practice social distancing when possible and avoid close contact with others. This may include staggering work schedules and decreasing social contact in the workplace.

Decisions about the implementation of community measures will be made by local and state officials, in consultation with federal officials as appropriate, and based on the scope of the outbreak and the severity of illness. Implementation will require extensive community engagement with ongoing and transparent public health communications (CDC).

#### **Prosperity Indiana's Response**

As of July 15, Prosperity Indiana team members are able to return to the office to work. Staff will be rotating days that they are present in the office. While most team members continue to work remotely at this time, we have compiled the following information about our return to work plan.

Our re-opening plan includes:

- Limiting staff in the office to no more than three at a time and fewer than 10 short-term, staggered visitors daily to allow for physical distancing
- Providing adequate PPE for staff and visitors, along with extra hand sanitizing supplies, tissues, and wipes for high touch surfaces.
- Implementing a return-to-work plan that complies with the Back on Track Roadmap, CDC, Indiana Department of Health, and OSHA guidelines.
